The TCA requires all exhibits to fit within the confines of the allotted 8'x8' exhibit space. Include display specifications on contract in space provided on registration forms. Dismantling of booth space to accommodate displays, equipment, etc. is prohibited.

\$800/single booth space (when registration is received by July 22)

\$1550/double booth space (when registration is received by July 22)

Additional fees may include: Electrical and/or other vendor display needs at exhibit location.

In order to secure electric for your space, you must complete hotel Exhibitor Utility Order Forms and submit to hotel.

You must note on your contract if you plan to bring large pop-up displays or stand-alone equipment. Items not pre-notified and pre-approved will be asked to be removed.
